 IX. Doctoral degree candidate qualification examination: 1. Graduate students who have completed the minimum period of study, fulfilled all required courses and credits, and prepared the outline and basic content of their degree dissertations may apply for a doctoral degree candidate qualification examination. The students are deemed to have passed the examination if at least two-thirds of the examination committee members agree so. 2. Candidates must complete the required graduation credits and submit proof of English proficiency as specified in Chapter 1, Article 1 of the 'NCHU Department of Animal Science Regulations for Ph.D. Candidate Qualification Examination and Graduation Requirements'. 3. The progress of the doctoral dissertation will be assessed through an oral examination. If the candidate fails, they may apply for a re-examination. Failure to pass the re-examination will result in dismissal. The doctoral candidacy qualification examination must be completed by the end of the eighth semester of enrollment. 4. - 1. Graduate students must obtain proof showing that they have completed graduation score. academic ethics education courses prior to applying for their dissertation Graduate students may complete self-directed learning defense. Relevant qualifications are determined by the respective through the Center for Taiwan Academic Research departments/graduate institutes/degree programs.
- 2. Students who have passed their doctoral degree candidate qualification obtain certification. Departments/graduate examinations and who have completed a draft of their dissertations shall, institutes/degree programs may require students to take after registering and enrolling for the semester, apply for the dissertation additional professional academic research ethics defense; they shall apply for the defense at least 20 days before the scheduled training courses in accordance with their own defense date. A passing score for the defense is 70.

XI. Other: English proficiency graduation requirements: (Specify if the The departments/graduate institutes are authorized to set department/graduate institute has no set requirements)

- (1) Prior to applying for the dissertation examination, the candidate must have published or had accepted at least two papers in academic journals, with at least one paper published in an SCI or SSCI journal (excluding papers submitted for the doctoral candidacy qualification examination). The candidate must be the first author.
- (2) Before applying for the dissertation oral defense, the candidate must have participated in at least two academic conferences and presented research related to their doctoral dissertation.
- (3) The dissertation oral defense committee members shall be nominated by the advisor and recommended upon approval by the department's Admissions and Examination Committee.
- (4) If deemed necessary by the advisor, the candidate must assist in at least one credit-bearing student internship course per semester for at least two semesters before graduation.
- (5) Before or during the semester of the dissertation oral defense, the doctoral candidate must present their research findings at a departmental seminar.
- (6) The doctoral candidate must fulfill the graduation requirements outlined in the curriculum guidelines of their admission year before applying for the dissertation oral defense.

Dissertation defense score accounts for 50% of the

Students who failed their dissertation defense but have not yet reached the maximum study period may register for the following academic year or semester to retake the examination once. For retakes, a passing score of 70 or above will be recorded as 70. Those who fail their dissertation defense twice will be dismissed.
